Such candidates must apply separately to Institutes for admissions to seats other than CAP Seats. Merit of such candidates shall be prepared by the Institute at the institute level.
3. Facility of Online Registration & Documents verification, confirmation of Application Form for Admission to Seats other than CAP Seats shall be continued till 27<sup>th</sup> August 2018 up to 5.00 PM at FC.
4. The candidates are required to produce the documents in original for verification and Confirmation of Application Form at R.S.C. Institute of Pharmacy, Kolhapur.
5. The Seat Acceptance Fee shall be as prescribed by fees Regulating Authority for all candidates. The candidates has to pay the Seat Acceptance Fee during first reporting only. This fee is non-refundable.
